#### Goals to be achieved in the next 5-6 years:

- 1. Full coverage of domestic demands
- 2. Lowest price per KWh offered to local and foreign consumers
- 3. Albania becomes the Regional Energy Power (Strategic target)

Current HPP production =1.600MW
Current HPP exploitation = 35%
