













#### OSCE Field Operations, South-Eastern Europe



# OSCE Mandate in Energy Security Dialogue



### Role of OSCE in Energy Security

- The world's largest regional security organization, a unique role to play in the field of energy security.
- ➤ Participating States include many of the world's leading energy producers, energy consumers, and transit states.
- ➤ Energy transit routes and related issues that have major implications for world energy markets often involve OSCE participating States.



## Mandate of OSCE in Energy Security

OSCE involved with Energy Security since 2003 Maastricht Strategy Document for the Economic and Environmental Dimension.



### Mandate of OSCE in Energy Security

Maastricht was followed by 3 MC Decisions from 2006 to 2009

1. Brussels Ministerial Council Decision No. 12/06: "Energy Security Dialogue in the OSCE"



- 2. Madrid Ministerial Council Decision No. 6/07:

  "Protecting Critical Energy Infrastructure from Terrorist Attack"
- 3. Athens Ministerial Council Decision No. 6/09: "Strengthening Dialogue and Co-operation on Energy Security in the OSCE Area"

### Specific Thematic areas for engagement:

- Promoting good governance, transparency in the energy sector;
- Continued focus on addressing threats to critical energy infrastructure;
- Promoting sustainable energy solutions;
- Promoting increased awareness regarding linkages between energy security & climate change;
- ➤ Possible role in confidence building and development of early warning mechanism.










# Programmatic Activities in Energy in SEE region

## OSCE Energy-related Activities in Albania

- ➤ Through ENVSEC initiative, the presence in Albania promoted the Extractive Industries Transparency Initiative (EITI), march 2014, 2 regional meetings on mining and oil.
- Followed by a High-level workshop to promote EITI at national level, April 2014.
- ➤ On o5 June, during International Environmental Day, the Aarhus Information Centre Vlora organized a roundtable with the topic "Initiatives in the field of Renewable Energies an important step towards Sustainable Development", held in Orikum municipality, Albania.

- ➤ The OSCE stands ready to continue its co-operation with partners.





#### MC Decision No. 12/06

Approved by MC in Brussels, December 2006;

Expressed support for the principles/objectives agreed at G8 summit in St. Petersburg;

Tasked PC and Secretariat to promote energy security dialogue including at expert level;

Tasked PC and Secretariat to raise awareness & enhance dialogue on G8 Action Plans on climate change, clean energy & sustainable development (2005) and energy security (2006).



#### MC Decision No. 6/07

Approved by MC in Madrid, November 2007;

Adequate protection of critical energy infrastructure from terrorist attack;

Promotion of public-private partnership in this field;

Tasked Secretary General to examine/report on opportunities for co-operation with relevant int'l orgs;

Facilitate exchange of best practices and timely exchange of information.



#### MC Decision No. 6/09

Approved by MC in Athens, December 2009;

Tasked PC to organize an expert meeting [Vilnius 2010] to assess OSCE's contribution to energy security co-operation;

Tasked Secretary General to write report on complementary role of OSCE in energy security;

OCEEA to support best practices and build capacity in areas related to energy security, incl. energy efficiency, energy savings, and development/investment in renewable energy.



#### MC Decision No. 5/13

Approved by MC in Kiev, December 2013;

Tasked the OCEEA to promote sustainable energy and foster transboundary co-operation;

Tasked the OCEEA to continue supporting awareness raising on the impact of energy-related activities on the environment;

Encourageed pS to explore the OSCE's possible role in supporting the UN post-2015 development agenda and in the UN/World Bank Sustainable Energy for All Initiative.



#### MC Decision No. 6/13

Approved by MC in Kiev, December 2013;

Tasked the OCEEA to identify opportunities for co-operation with international organizations and regional organizations and agencies in the field of protection of energy networks against natural and man-made disasters and to facilitate discussions on possible areas for co-operation;

Tasks the OCEEA to facilitate the exchange of good practices, technological innovations and the sharing of information on effective preparedness for, and responses to, disaster risks to energy networks.
